3,103 participants

Professional Development for Educators

4-C's Training Department offered professional development opportunities for child care providers via face-to-face workshops, online eCourses, customized on-site workshops, a community conference, and Communities of Practice, among others, to 3,103 statewide participants who attended 634 unique events earning a total of 1,555 clock hours.

Food Program for Child Care Centers & Homes

4-C sponsored 34 Child Care Centers in the USDA's Child and Adult Care Food Program that received \$1,015,875 in meal reimbursement in return for serving 539,618 nutritious meals and snacks to children in their programs and 74 Family Child Care Home Providers that received \$392,961 in meal reimbursement in return for serving 222,358 nutritious meals and snacks to children in their programs.

Head Start Services

4-C, working in partnership with Family & Children's Place, offers the Greater Louisville Head Start program – a free program that will ultimately help nearly 450 families each year by enhancing each child's growth and development, strengthening parents' ability to nurture their child, connecting families with needed community resources, and providing children with educational, health, and nutritional services. This year, families were able to choose between daily programs at five 4-C partner learning centers around Louisville.

Partner Programs

Some program offerings of note for this year include: partnering with KYA in the Kosair Charities Face It® Movement to help recognize and end child abuse; partnering with the James Graham Brown and C.E. and S. Foundations in the Pathways to Excellence program to support child care centers in low-income areas of Jefferson County with professional development opportunities.



Advocacy

4-C maintains a pro-active public policy program, with the goal of influencing local, state, and national child care policies and serves as a voice for children and families. We carry out these program goals by identifying and developing resources for families and child care programs; partnering with business, government, and communities to demonstrate that child care is critical to social wellbeing and economic development; and collecting, developing and disseminating information about child care programs.

Help for Families

4-C's Information and Referral program matches parents seeking child care with local child care providers that meet their family's needs. Our website provides 24 hour access to valuable tools and information about child care services, news, advocacy alerts, and abuse prevention, among others.
